

CONSENT TO THE PROCESSING OF PERSONAL DATA

I, confirm my consent to processing my personal data using automation and / or without the use of such resources to AstraZeneca group of companies, namely: OOO «AstraZeneca Pharmaceuticals» (OGRN 1057749225830, Russia, Moscow city, 1st Krasnogvardeisky drive, 21, b 1); AstraZeneca Pls (1st Francis Creek Avenue, Cambridge Biomedical Campus, Cambridge CB2 0AA, GB) and its subcompanies (further «AstraZeneca»), OOO «AstraZeneca Industries» (OGRN 1104029001702, Russia, 249006, the Kaluga region, Borovsky district, Dobrino village, 1st Vostochny drive, 8), AstraZeneca UK Limited (1st Francis Creek Avenue, Cambridge Biomedical Campus, Cambridge CB2 0AA, GB) and its subcompanies (further «AstraZeneca») – further «Operator».

This Consent is given to the Operator for the purpose of considering my candidacy (including assessment of professional, business and personal qualities, including testing) for current and future vacancies, i.e. the inclusion of me in the external candidates pool of the Operator.

This Consent is also given for the purpose of checking recommendations on my candidacy, according the contacts I provided, information on seniority, participation in organizations, as well as information of the presence or absence of administrative and criminal liability.

This Consent is issued on the processing of the following list of personal data:

- the information provided in this Consent, contained in the identity documents;
- recruitment information (the information contained in the CV and the questionnaire, performance characteristics and recommendations from the previous places of work);
- information on education, qualification or availability of special knowledge or training;
- photo, including in digital format (if available).

The list of actions with personal data the performance consent is given for, a general description of the processing methods used by the Operators using automation tools and / or without using such tools necessary to achieve the purposes of data processing, including:
